Save Our Beach Association, a non-profit, nonpolitical group whose purpose is to preserve and beautify our beaches is hosting its sixth annual craft show and market days, combined with the fourth annual Surfside Flyers' Kite Club demonstration. Proceeds from this show help fund our Christmas tree project and our beach renourishment efforts.

## **General Information:**

We are seeking vendors of fine art, quality crafts, food, quality collectibles, and antiques. SOBA encourages vendors to provide an item for a silent auction prize. Please provide a 5"x7" or smaller card with information about your show offerings if you would like us to show such advertising with your donation. Prizes will be on display to help potential customers find vendors with items that particularly interest them and to keep those shoppers hopeful of winning a particular prize shopping.

Our "Treasures by the Sea Market" will have entertainment and activities for the children to bring in the shoppers. This year's entertainment will include an incredible kite flying display with great viewing from the Stahlman Park venue. The date also coordinates with the motorcycle expo in neighboring Galveston, TX.

Inside and outside spaces are available. In addition to the purchased space(s), vendors will, upon request, be provided two (2) chairs per space for use during the event at no additional charge. **Tables will be available upon request for a small additional charge as detailed below**. Ample aisles are provided in front of all spaces. Access to sides of your display space will depend upon your location. Tarpaulins will be provided for weather protection if necessary.

Setup will begin at 7 am on the morning of the show. Customers will be admitted at 10 am. The event will close at 5 pm. Unless vendors have a legitimate reason, vendors are required to remain until end of show (\$15 early withdrawal fee). You may not hang anything on walls. If you require electricity, a wall booth or downstairs space is also required. Vendors who need electricity must pay a small fee if the nature of use warrants such a charge. (Examples include but are not limited to food vendors who are using electricity to prepare or keep food hot or cold or a lamp vendor who uses electricity to light up a large number of display items.)

Payment is due with application. SOBA accepts cash, checks, and money orders. Make checks and money orders payable to SOBA. You can also pay by PayPal by accessing our website <a href="http://sobatx.org">http://sobatx.org</a>. You can link to PayPal portal by clicking "Please click here to pay your association dues now." Please enter "Vendor" in the "description" field. Applications are subject to space availability and suitability. SOBA will work to avoid duplication of offerings. All other factors being equal, SOBA will accept the earliest application upon discovery of duplication is discovered. This does not mean that we shall not host several jewelry makers; it just means that if two vendors offer similar styles, we shall accept only the first application. We cannot accept incomplete applications.

Collection and reporting of sales tax is vendor's responsibility. Vendors preparing food on site are required to have a health license from Brazoria County. At the show, after you have unloaded your wares, please park across the street at the crabbing pier to provide parking for our customers.
